### THE ACADEMY GE FELLOWS PROGRAM

The Academy GE Fellows Program is a comprehensive two-year leadership development program designed for high-potential administrative, financial, nurse, and physician executives. The Fellowships are an outstanding opportunity for exceptional leaders who have been selected to assume C-suite or other significant leadership positions within their health system.

### ACADEMY GE FELLOWS PROGRAM FOR PHYSICIAN EXECUTIVE FELLOWS

The Physician Executive Fellows program offers physician executives the unique opportunity to develop an expert network of similar high-achieving executives, broaden their leadership expertise, gain knowledge of leading health system strategies and better understand the practical steps required for success. What's more, Physician Executive Fellows become part of an elite network of multidisciplinary Fellows program alumni with opportunities to participate in Academy activities.

### EXPERT FACULTY-DRIVEN PROGRAM AND CONTENT

Through a unique collaboration with The Academy membership, the program and content reflects the leadership requirements of today's Top-100 health systems. The Fellows Advisory Committee, Consulting Faculty and Executives-in-Residence all contribute to Fellows developing skills and strategic perspectives necessary to assume positions of increasing responsibility in their Top-100 health system.

### RESULTS-ORIENTED CURRICULUM ACCELERATES SKILL DEVELOPMENT

Physician Executive Fellows are carefully nominated and mentored by leadership within their health system, usually the CMO or CEO. Only six to eight highly-qualified Fellows are selected for each class. The curriculum is designed to accelerate skill development. The Physician Executive Fellows' curriculum comprises:

- **GE Crotonville Seminar** – Physician Executive Fellows attend a two-day interdisciplinary seminar with Financial, Nurse and Administrative Executive Fellows, Mentors and Advisory Committee members, hosted by GE at the internationally known John F. Welch Leadership Development Center.
- **Fellows Annual Meetings** – The Annual Meeting is held in conjunction with the CMO Forum meeting. Content is designed specifically for the Fellows with the added benefit of participation in the CMO meeting.
- **The Academy Forum Rotations** – In addition to attending the CMO Forum, Physician Executive Fellows choose to attend two additional Forum meetings such as SrE, CFO, CEO, etc.
- **Action Project** – All Fellows will select, lead and report on a system-level project within their health system.
- **Program Electives** – Physician Executive Fellows have the option to participate in electives, such as attending the Government Relations Officer Forum meeting in Washington, D.C.

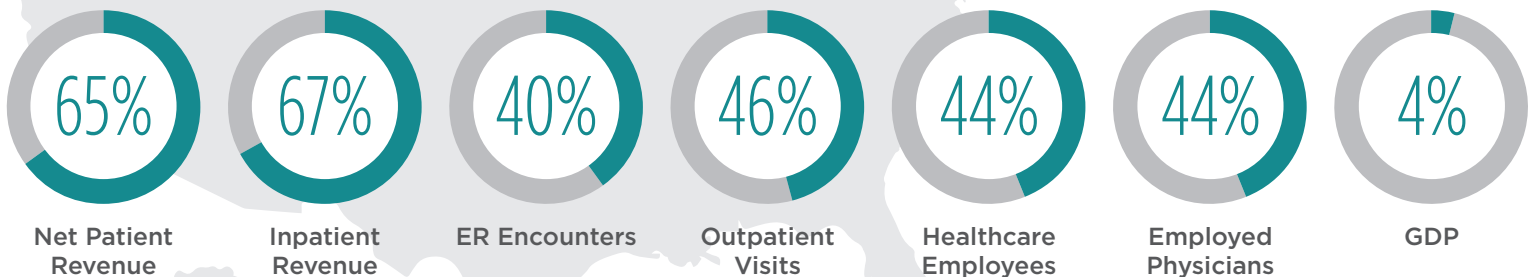
